Terms and conditions

- Terms and conditions applicable to the Hollard Highway Heroes Competition 2024 ("Competition") conducted by Hollard Trucking, a division of Hollard Insure, underwritten by The Hollard Insurance Company Limited (Reg. No. 1952/005004/06), a Licensed Non-Life Insurer and an authorised Financial Services Provider ("Promoter").
 - The Competition runs from 01 April 2024 to 15 October 2024. Entry forms for this Competition will only be accepted from 1 April 2024 to 31 May 2024. Entry forms received after 31 May 2024, will not be considered.
 - Hollard is looking for the Hollard Highway Hero for 2024. The Hollard Highway Hero will be the driver who comes out tops, in our exclusive view after the Promoter examines his telematics data and performs a technical analysis of his driving.
 - The measurement for determining the Hollard Highway Hero will include a combination of analysis by Hollard of the driver's data supplied by the Fleet Owner, in-cab camera device (this will apply to drivers selected in the Top 20 Phase of the Competition) as well as an analysis of the driver's results through telematics data.
 - This Competition is open to drivers ("Driver Participants") employed by fleet owners ("Fleet Owners").
 - The buses driven by the Driver Participants must carry a minimum of 36 passengers. The buses must have a top of the range telematics system (GPS/GRSM/Satellite unit) installed and functioning from the date of entry until submission of the telematics data. The minimum data requirement is raw data reports indicating the total count of speeding events per specified date range above the speed of 100 (one hundred) kilometres per hour (km/ph) for longer than 15 (fifteen) seconds; the total excessive driving day counts per specified date range (any continuous driving event over 150 (one hundred and fifty) kilometres or 2:15 (two and a quarter hours) and excessive driving night counts per specified date range are any continuous driving event over 150 (one hundred and fifty) kilometres or 2:15 (two and a quarter hours) for the specified date range. All monitoring data should be provided weekly and within 48 (forty-eight) hours of the request being made by the Promoter and should be provided in a raw data CSV format. Should the drivers not be tagged, all reports should be accompanied by driver logbooks indicating which driver was responsible for which bus for the specified date range.
 - The telematics data for the Driver Participant is required in order for the Driver Participant to participate in the Competition. If the Driver Participant drives more than 1 (one) bus for the Fleet Owner, the data from any and all of those buses may be used.
 - The Driver Participants must be permanently employed by the Fleet Owner and must remain in their employ for the duration of the Competition and up until the winners are announced. Termination of employment for any reason whatsoever will result in the Driver Participant being disqualified from the Competition.
 - Participants (Driver Participants) ("Participants"/"you"/"your") must be 18 (eighteen) years or older and have a valid South African identity document or passport. Driver Participants must have a valid driver's licence and valid permits to drive the bus(es). Foreign nationality drivers can also enter the Competition should they have a valid foreign driver's licence, valid South African issued working and driving permits and identification document available.
 - Participants may not enter or receive a prize if they are directors, members, partners, employees, agents of or consultants of the Promoter, The Hollard Group of Companies or of the advertising or promotion agencies or any other person who directly or indirectly controls or is controlled by the Promoter, or their spouses, life partners, or immediate family members.
- How to enter**
- Driver Participants wishing to enter must be nominated by the Fleet Owner (their employer). All identification documents will be audited and verified should the driver advance to a category winner.
 - The onus is on the Fleet Owner to ensure consent is obtained from the Driver Participant to enter him into the Competition. Should a Driver Participant not wish to participate, the entry will be disqualified.
 - Entry forms available on www.hollard.co.za/highway-heroes must be completed and sent to highwayheroes@hollard.co.za. Entry forms will also be available from Hollard Commercial Vehicles consultants, at selected Hollard branches.
- Steps for the Driver Participant to be eligible for the Hollard Highway Hero analysis:
 - Step 1: Completed entry form submitted, received and verified by Promoter.
 - Step 2: Fleet Owners must provide the Promoter with the telematics data and driver logbooks of the Driver Participant on a weekly basis during the monitoring period from 01 June 2024 to 15 October 2024. All data should be provided within 48 (forty-eight) hours of the request from the Promoter.
 - Step 3: Optional extra motivation - Fleet Owner may send the Promoter a written motivation about an event or scenario where the Driver Participant acted in essence as a hero.
 - Step 4: If selected by Hollard (in their exclusive discretion) as a top 20 (twenty) Finalist, the Driver Participant must participate in a 45-(forty-five) day telematics assessment, at a time to be determined by Hollard. In addition to the above, Hollard will require every participating truck to be fitted with an in-cab camera device which will be monitored by Hollard for the purposes of the Competition. The Driver participant and the Fleet Owner must ensure that the in-cab camera device is always functioning within the 45-(forty-five) day assessment.
 - Entry forms will be accepted until midnight on 31 May 2024. Step 2 must be completed weekly and upon request by the Promoter during the Competition period.
 - Eligible entries received will be assessed throughout the Competition and 20 Driver Participants will be shortlisted as respective category winners.
 - Some Driver Participants may, subject to their prior consent, be profiled on the Hollard website (www.hollard.co.za/highway-heroes) and/or in the Hollard Commercial Vehicles newsletter and within any other media outlets/partners.
 - Should certain Driver Participants agree, the Promoter may wish to use some Driver Participants in marketing collateral by the Promoter, including but not limited to, on the Promoter's Facebook page or website. This will be without any liability to the Promoter and there will be no remuneration due and owing to the Driver Participants, Fleet Owners or any third parties.
 - A Fleet Owner can enter as many Driver Participants as they wish.
 - A driver may only win once per category in the 8-month competition cycle.

Prizes

- The Driver Participant who is announced as the Hollard Highway Hero will win cash to the value of R150 000 (one hundred and fifty thousand rand) ("Grand Prize"). Each category winner will win R20 000 (twenty thousand rand) cash paid into their verified accounts.
- All Driver Participants who win prizes in terms of this Competition each win in their personal capacities and the prize is for personal use.
- The prizes cannot be transferred to another person or format and do not cover any other costs of the winner whatsoever.

Determination of winners

- The Promoter will make 3 (three) attempts within 72 (seventy-two) hours to contact and notify the selected winners or Finalists telephonically. If the selected winner or Finalist cannot be contacted personally after 3 (three) attempts, or if after first being contacted by the Promoter, is not reachable, or the winner fails to provide the Promoter with the required information to hand over the prize, the winner will forfeit the prize and a replacement winner will be selected from the remaining qualifying participants. This process shall continue until the winner has been contacted and the prize has been awarded in terms of the Competition rules.
- An awards ceremony will be hosted at the Venue to be communicated by the Promoter where the prize and certificate winners in each category will be awarded around November 2024, after the monitoring is completed. Alternative arrangements with regards to the announcement of the winners and the delivery of the prizes are at the Promoter's sole discretion.

General
