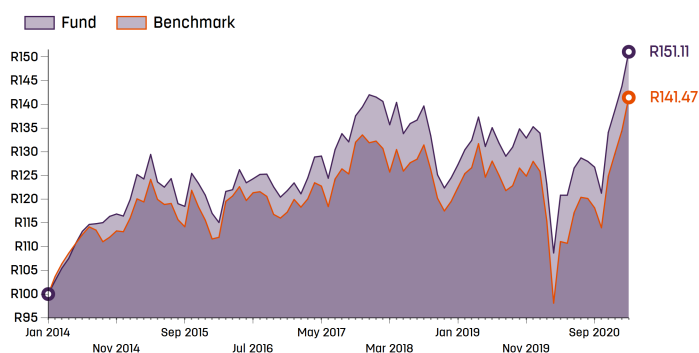

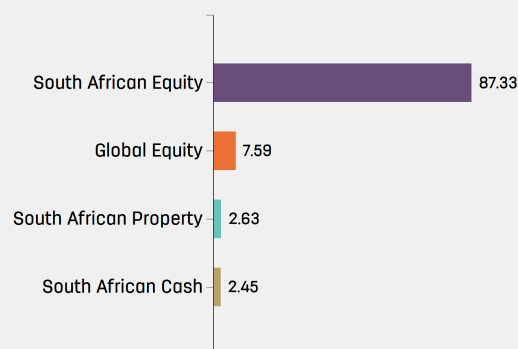
- > Seek exposure to JSE-listed equities to provide long-term capital growth

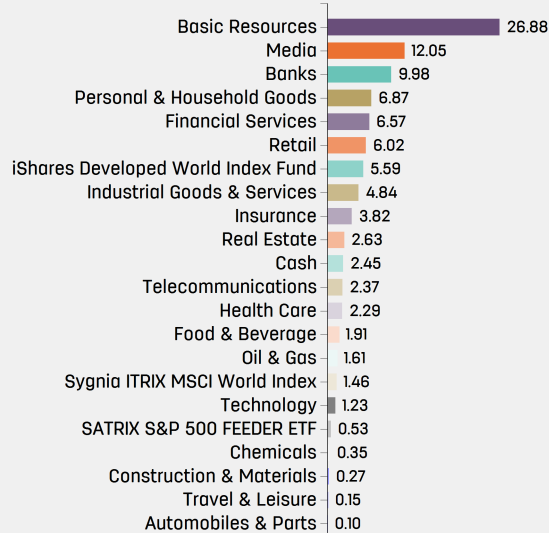

Sector Allocation (%)



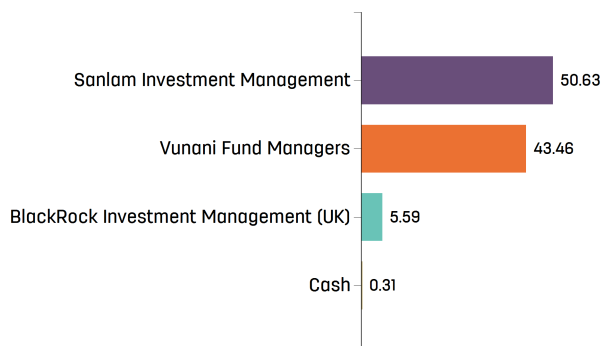
