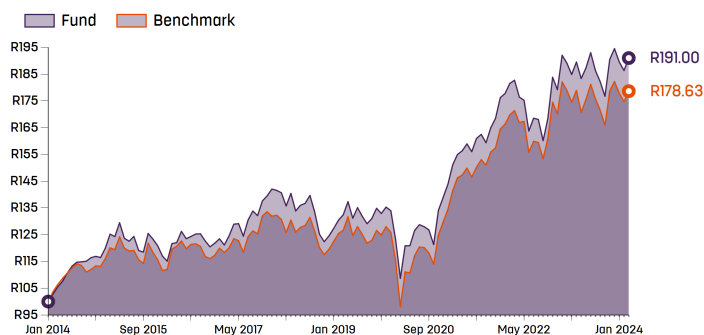

- > At least 80% of assets to be invested in equity securities

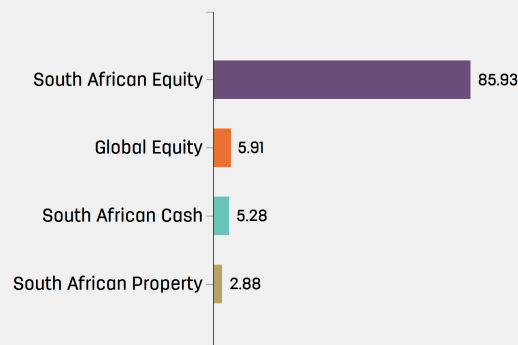
This fund is suitable for those investors who:

- > Wish to use the Fund as an equity "building block" in a diversified multi-asset class portfolio

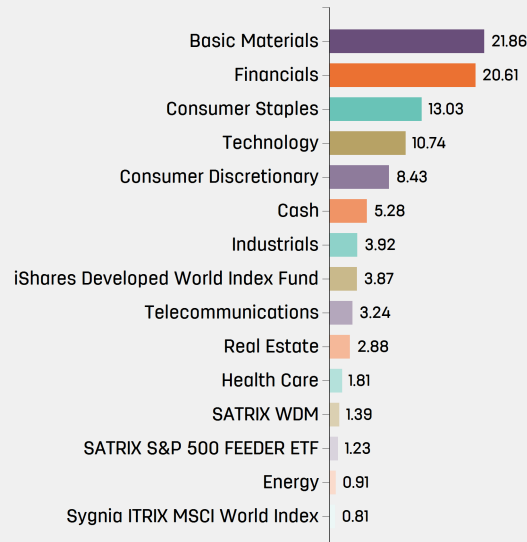

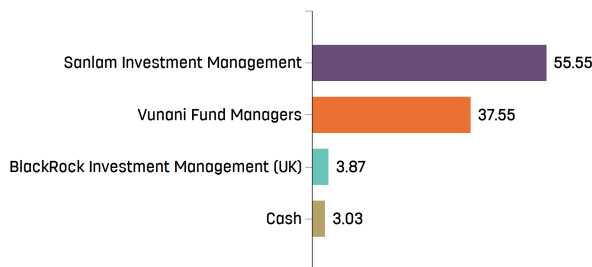
